Joanna Barrkman is the Curator of Southeast Asian Art and Material Culture at the Museum and Art Gallery of the Northern Territory. Her MA (Research) thesis, through Charles Darwin University, is on the influence of Indian patola and trade cloths on the textiles and rituals of the Atoin meto people of West Timor. Joanna holds postgraduate qualifications in Heritage and Museum Studies (Deakin University) and Indonesian Studies (Charles Darwin University). She is currently a member of the International Council of Museums (ICOM) Australian National Committee.

Cath Bowdler is an artist, curator and arts writer and a PhD candidate at the Centre for Cross-Cultural Research at the Australian National University. She has previously lectured at Charles Darwin University in Art History and Theory and was the Director of 24HR Art gallery in Darwin. Her recent curatorial work and research has been focused on Indigenous and non-Indigenous visual contemporary art practices in the Northern Territory.

Paul Clark is the founding Curator of Maritime Archaeology and History at the Museum and Art Gallery of the Northern Territory. In addition to curating an historic boat and ethnographic watercraft collection, Paul also manages an historic shipwrecks program. Current research interests centre on maritime communities in eastern Indonesia with a particular focus on the design, construction and use of traditional watercraft as well as contemporary issues surrounding Indonesian fishing activities in Australian waters. Paul is currently enrolled in a Master of Arts degree at Charles Darwin University. His topic is Indonesian fishing boats in Australian museum collections.

Steven Farram works as a Research Associate in the Faculty of Law, Business and Arts at Charles Darwin University. His doctoral thesis, completed at Charles Darwin University, was titled 'From "Timor Koepang" to "Timor NTT": A Political History of West Timor, 1901-1967'. He graduated in May 2004.
